AND WHEREAS Council requested further information from MB Conservation and Climate including a clearer map showing the proposed potential zones established for these purposes and their relation to the TransCanada Highway and all relevant property within the RM of Ste. Anne, this which was received and reviewed by Council at this December 16, 2020 regular meeting;

BE IT RESOLVED that Council express concerns to MB Conservation and Climate in relation to Manitoba's permit system for rights-based hunting on Crown land in southern Manitoba, specifically requesting changes to the Night Hunting Southern Designation Area map to clearly show the following:

RM of Reynolds Invoices and Inter-Municipal Road Maintenance Agreement

WHEREAS in July 2019 arrangements were made between RMs of Reynolds and Ste. Anne Public Works department managers to complete regular road maintenance on Road 48E, south of the TransCanada Highway;

AND WHEREAS this work would typically be completed by the RM of Reynolds at their cost but were instead completed by the RM of Ste. Anne at our cost, with 50% of the costs invoiced back to the RM of Reynolds through Invoice #'s 20190151 and 20190159;

AND WHEREAS the RMs of Reynolds and Ste. Anne entered into an Inter-Municipal Road Maintenance Agreement in March 2020 with provisions, amongst others, for the portion of inter-municipal Road 48E, south of the TransCanada Highway, to be provided regular road maintenance works by the RM of Reynolds at 100% their cost;

AND WHEREAS in lieu of the new Inter-Municipal Road Maintenance Agreement, the RM of Ste. Anne has been notified by the RM of Reynolds that they will not be paying for any of the works completed by the RM of Ste.
