THE RURAL MUNICIPALITY OF STE ANNE

BY-LAW No. 7-2011

BEING a By-Law of the Rural Municipality of Ste. Anne to prescribe fees and charges for services, activities or things provided or done by the municipality.

WHEREAS the Council of the Rural Municipality of Ste. Anne deems it expedient and advisable to include in one by-law the fees and charges payable to the municipality for certain services rendered by officers and employees of the municipality;

AND WHEREAS Section 232(1) of *The Municipal Act* provides that a Council may pass By-laws for municipal purposes respecting the following matters pertaining to:

Exercising by-law-making powers

232(2) Without limiting the generality of subsection (1), a council may in a by-law passed under this Division

(d) establish fees or other charges for services, activities or things provided or done by the municipality or for the use of property under the ownership, direction, management or control of the municipality;

NOW THEREFORE the Council of the Rural Municipality of Ste. Anne enacts as a By-Law the following:

- 1. That this By-Law be known as the Fees and Charges By-Law;
- 2. That the fees and charges that the Rural Municipality of Ste. Anne shall charge are set out in Schedule "A" attached to this by-law;
- 3. That Council, from time to time by resolution, may amend Schedule "A" attached to this by-law;
- 4. That the fees and charges set out in the attached schedule to this by-law shall take precedence over any other by-law;
- 5. That any unpaid fees or charges owed to the Rural Municipality of Ste. Anne by any taxpayer including any penalties related thereto, as well as any fines imposed on the taxpayer, and any unpaid fees or fines, not paid within 90 days, may be collected or enforced in the same manner as a tax as defined by the Municipal Act;
- 6. That this By-Law shall come into force and take effect on the passing thereof;
- 7. That By-Law No. 13-1998 and No. 9-1997 be hereby repealed.
