- Areas Affected:**
1. Pt. NW 16-8-8E, Lot 5 Plan 62307, 67 Dawson Road, being the Dawson Trail Museum;
 2. Pt. NW 16-8-8E, Lot 6 Plan 62307, being the Richer Catholic Cemetery
- Intent:** To repeal By-law #05-2008 and to re-designate the properties commonly known as the Dawson Trail Museum and the Richer Catholic Cemetery as Municipal Heritage Sites
