PUBLIC HEARING REGARDING CONDITIONAL USE APPLICATION NO. 07-2006

The minutes of a public hearing to consider Conditional Use Application 07-2006 made by Peter Gerzen on behalf of Gerzen Construction. Public notice was sent by regular mail to all assessed owners of property within 100 metres of the subject property in accordance with Section 105 of the Planning Act.

Owner/Applicants: Peter Gerzen on behalf of Gerzen Construction

Subject: To allow a gravel extraction operation in an area zoned 'AG' Agricultural General.

Location: Part NE 7-7-7E

Reeve Art Bergmann called the public hearing to order at 8:00 PM with the following members of council in attendance: Councillors Courcelles, Saindon, Proulx, Massicotte and Evans. Also in attendance was the Chief Administrative Officer, Alice De Baets.
