AND WHEREAS the Municipality recently adopted Zoning By-Law No. 2023-13 to include Secondary Suites as a conditional use, permitted in certain zoned areas which reduced the restrictions;

AND WHEREAS Garden Suites falls within the definition of Secondary Suites, pursuant to the current Zoning By-Law;

AND WHEREAS some of the restrictions within the existing development agreements are no longer valid, as per the Municipality's current Zoning By-Law;

AND WHEREAS administration for the Municipality is seeking to assist registered owners who have existing development agreements that are now too restrictive;

AND WHEREAS section 3 of the Municipal Act provides the Municipality to provide good government and to develop and maintain safe and viable communities;

NOW THEREFORE Council for the Municipality believes that it is in the Municipality's best interest to assist ratepayers correct irregularities from the Zoning By-Laws, and confirms the following:

- 1. Administration for the Municipality shall assist all owners who wish to amend or discharge a portion of the development agreement which overly restricts the use Garden Suites (such as removal of the Garden Suite), which are now Conditionally permitted to remain as a Secondary Suite pursuant to Zoning By-Law No. 2023-13.
- 2. The Municipality shall cover all costs associated with the process.

BE IT RESOLVED that Conditional Use #02-25 & Variation Order #01-25 be conditionally approved, subject to the following:

- 1. A Development Agreement shall be registered on the title, including but not limited to the following conditions:
  - Short-Term Rental Conditions
    - The maximum number of overnight adult guests permitted in the short-term rental shall not be more than 16.
    - The short-term rental must provide five (5) parking spaces, entirely within the parcel on which it is located.
    - The applicant must obtain the necessary building permit, if required, to the satisfaction of the designated officer. This may include a final inspection by the Fire Chief to ensure compliance with safety regulations.
    - The applicant shall maintain the short-term rental unit in a clean and sanitary condition and operate it in accordance with all current municipal by-laws.

#### • Special Event Facility Conditions

- The maximum number of guests permitted for events at the facility shall not exceed
  50
- The facility may operate from 9:00 AM to 11:00 PM and all music to cease by 11:00 PM (From May to end of September).
- The applicant must provide adequate waste management and site maintenance.
- A minimum of 20 parking stalls, plus one space per employees, must be provided.
- The applicant must install appropriate signage and lighting for pathways, driveways and property line to satisfaction of the municipality.
- The applicant must provide accessible washroom facilities.
- If alcohol is to be served, the necessary licenses must be obtained by the developer or guests, and the developer shall be responsible for ensuring compliance with all licensing regulations
- Fencing for parking area is required
- During events at least one (1) security person per 50 guests is required.
- Sound barrier and fencing may be required on parts of the property upon request of municipality.
- The applicant must construct and maintain a 20-foot-wide driveway surface to accommodate emergency services.

#### • General Conditions (Applicable to Both Uses)

- Any costs related to this application shall be paid by the applicant.
- The applicant must obtain a development permit from the RM of Ste. Anne.
- The applicant shall demonstrate full compliance with all relevant federal, provincial, and municipal regulations, including but not limited to the RM of Ste. Anne Noise Bylaw and Animal Control By-law.
- The applicant shall provide proof of adequate damage and liability insurance coverage to the Development Officer upon request.
- The applicant shall retain the current letter of intent submitted. Any changes in use or modifications will require new approval.

• Parking shall not be permitted on municipal roads or highways.
