# MIT Cost Share Initiative 272-10 Evans - Massicotte

WHEREAS the RM of Ste. Anne Councillor Laurie Evans and MIT Maintenance Superintendent Gary Dyck have been in discussion to clean out approximately 3.1 km of the North ditch along PR#207 (Dawson Road) from the westerly border of the Town of Ste. Anne to Intermunicipal Road 48N;

BE IT RESOLVED that the RM of Ste. Anne will undertake this project in consultation with MIT on the following conditions:

- a) That the clean out is to be done from culvert to culvert as per profile provided by MIT with no modification to any existing culverts;
- b) That the ditch is to have a 10ft bottom and a 4:1 slope ratio as per MIT specifications provided;
- c) That all material removed from the ditch will be windrowed on the edge of the adjacent land, and that the land owner is responsible to deal with the windrow as he/she see fit;
- d) And, that the RM of Ste. Anne and MIT will cost-share in the project 50/50 up to a maximum of \$5,000 per party.
