1) **Roll #64190** that the land assessment for 2011 be confirmed.

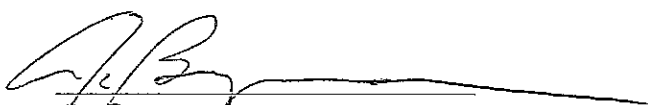

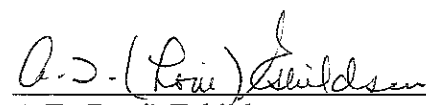
