- a) A septic field suitability study, prepared by a qualified engineer, providing an assessment of soil conditions throughout the subdivision area including particle size analysis, surficial soils logs and test drilling to determine the depth of groundwater and / or ground saturated conditions. Further, the report should also include recommendations of the preferred type of sewage disposal system, typical design and placement of the septic system on the proposed lots;
- b) An Engineered Drainage Plan, prepared by a professional engineer and presented to council showing the drainage from the proposed subdivision into municipal ditche(s) and further into provincial drains / ditches.
