BE IT RESOLVED that the following policy be enacted for <u>all pre-existing structures</u> that require building permits under the authority of the current RM of Ste. Anne Building By-law prior to being lawfully allowed within the RM of Ste. Anne boundaries:

- 1) That prior to the issuance of the required permit, the building must be inspected by a qualified Structural Engineer, who is to submit a detailed, component by component, inspection report for the structure at the owner's expense, as per <u>Schedule 'A'</u> attached;
- 2) That a copy of the Structural Engineer's report must accompany the permit application, in order for the permit to be considered by council;
- 3) That upon review of this report, only buildings deemed <u>structurally sound</u> by a structural engineer will be considered for approval by Council;
- 4) That Council may require the following of any buildings:
 - a. Council may require remedial work to be done prior to permit approval;
 - b. Council will require the structure to be <u>re-inspected</u> and a copy of the re-inspection report will have to be re-submitted to council for permit approval; and
 - c. Council may allow the structure into the Municipality to do the remedial work, if needed;

- 5) That any structure(s) illegally located within the Municipality, deemed structurally un-sound, may be required to be removed from the property at the owners expense;
- 6) That all structures located in the Municipality must comply with all municipal and provincial requirements currently in place;
- 7) That this policy, approved at the May 23, 2012 council meeting, replace the existing policy, passed by Resolution #449-11.

Bldg Permit Deposit Policy

- c) That this deposit shall be held by the RM of Ste. Anne until the Building Inspector confirms that all inspections have been completed satisfactorily;
- d) That once all requirements have been met by the applicant, the RM of Ste. Anne shall refund the \$500.00 deposit;
- e) That the Council must first approve the payment of the \$500.00 refund cheque (without interest) at the next available meeting of Council prior to this cheque being released.

BE IT FURTHER RESOLVED that this policy, approved at the May 23, 2012 council meeting, replace the existing policy, passed by Resolution #84-12.
