BE IT RESOLVED that the application for approval to subdivide, identified by File #4175-2013-7162, is hereby approved on the following conditions:

- a) That the applicant obtain a Legal Plan of Subdivision and/or a Building Location Certificate, prepared by a Manitoba Land Surveyor, to determine the site widths, site areas and location of all buildings and/or structures including on-site wastewater management system(s) on the affected land in relation to the proposed property lines;
- b) That the applicant obtains any necessary variations as a result of the Plan of Subdivision and/or a Building Location Certificate;
- c) That the applicant obtains a site width variation for the residual parcel reducing the minimum site width from the required 200 feet in the "RR" zone to approximately 66 feet;
- d) That the applicant apply for a Road Order to create a new Public Road, being 66 feet wide, for proposed Phase 3 subdivision File #4175-2013-7162, for already approved Phase 2 subdivision File #4175-2012-5523 and already approved Phase 1 subdivision File #4175-2010-5129;
- e) That a contribution of \$750.00 per parcel created be paid to the Municipality for municipal purposes;
- f) That a Development Agreement be entered into with the applicant/developer and that all conditions of the proposed subdivision and Road Order be included in the Development Agreement to be registered as a caveat on the title; and

g) That all costs associated with the registration of the Development Agreement be borne by the applicant/developer.

WHEREAS a condition of approval of the application to subdivide Pt. NW ¼ 12-8-7E, submitted by Gary Vincent identified as File #4175-2004-3869, was the requirement to enter into a Development Agreement with the Municipality regarding the construction and maintenance of the road allowance and drainage;

AND WHEREAS Gary Vincent had agreed to enter into a Development Agreement with the municipality, regarding the road allowance identified as Parcel B, Plan 42344, only if and when there was further development of the property to the rear, namely Parcel 3, C & D Plan 42344;

AND WHEREAS the current owner, Schinkel Properties Inc., is now proposing to develop the mentioned properties and is therefore requesting that the Municipality enter into a Development Agreement with the Developer in regards to the construction and maintenance of the road allowance and drainage;

BE IT RESOLVED that a Development Agreement be entered into between the Developer and the Municipality providing for the following conditions:

- 1) That the Developer is to make the necessary arrangements to have the Development Agreement drawn up at no cost to the Municipality, for Council's review and approval by resolution, and to include the following:
 - a) The construction and maintenance of a private shared driveway presently described as Parcel B, Plan 42344;
 - b) That drainage associated with the private shared driveway be approved & licensed through MB Conservation & Water Stewardship;
 - c) A provision stating that the Municipality is not, and never will be, responsible for the maintenance of the private driveway, nor will it accept ownership of the private driveway at any point in time;
 - d) That the Development Agreement, including all conditions associated with the same and that the maintenance of the private shared driveway is the responsibility of owners accessing the private driveway, is to be registered as a caveat on the title of all properties abutting the private driveway;
 - e) That all costs associated with the registration of the Development Agreement, Caveats and the creation and maintenance of the private shared driveway, be borne by the Developer.
