PTH 12 Reconstruction

238-14 Courcelles - Saindon

WHEREAS Manitoba Infrastructure and Transportation (MIT) will be reconstructing the southbound lanes of PTH 12, from the interchange of PTH 1 to the Seine River Diversion bridges, and has installed temporary traffic signals on the intersection of PTH 12 and PR 210 for public safety reasons during the reconstruction;

AND WHEREAS this said intersection is a public safety concern to the Municipality outside of the reconstruction project, as there is a high traffic volume merging onto or crossing PTH 12;

BE IT RESOLVED that the RM of Ste. Anne request to MIT that these traffic signals are installed permanently to alleviate safety concerns not related to the reconstruction of PTH 12.

CN Railway Crossing System

240-14 Evans - Reimer

WHEREAS Transport Canada did meet with the RM of Ste. Anne in December of 2001 to discuss the initiation of improvements to CN Crossing Mile 125.26 Sprague Sub. & Seine Road, near the Town of Ste. Anne, in response to their concerns over safety risks to those using it, including restricted sight lines, poor roadway angles and close proximity to private driveway accesses;

AND WHEREAS it is the responsibility of both Transport Canada and the local authority to ensure that the crossing is meeting adequate levels of protection pertaining to the volume and type of traffic using the crossing;

AND WHEREAS all parties agree that the above mentioned crossing should either be closed or upgraded to eliminate all concerns pertaining to the safety of the crossing;

AND WHEREAS the Municipality is not in the financial position to absorb the entire cost of closing or improving the crossing to the appropriate standards;

AND WHEREAS some of the necessary infrastructure improvements would be located in the Town of Ste. Anne, where the Municipality is not the local authority and Council does not wish to incur all of the costs of those improvements as they are not assets to the Municipality;

BE IT RESOLVED that the Municipality shares the concerns of Transport Canada and CN Railway but does not wish to incur the expense associated with the project and encourages Transport Canada and CN Railway to improve the crossing to satisfactory standards at their cost, as the original railway placement in that location was under the organization and implementation of their departments;

BE IT FURTHER RESOLVED that, considering the longevity of discussions regarding this matter, the Municipality requests that the project is committed to and undertaken for the year 2015.

- c) That a shared driveway agreement is prepared for the affected properties by the applicant and is registered as a caveat on each resulting title;
- d) That the cost of the preparation and registration of the shared driveway agreement is to be borne by the developer;
- e) That the applicant obtain the necessary permits from MB Infrastructure and Transportation (MIT) to relocate the existing driveway; and
- f) That a contribution of \$750.00 per parcel created be paid to the Municipality for municipal purposes.

AND WHEREAS the conversion of these structures, once the Main House has been completed, will require additional inspections to ensure that the renovations are completed in accordance with current building codes;

BE IT RESOLVED that the following conditions apply to all approvals of permit applications pertaining to the above mentioned projects:

- a) That Garage-Residences, being residences that can be easily converted to garages in the future, will be permitted on the following conditions:
 - i. That the entire building meets the current residential building code requirements;
 - ii. That no garage doors are to be installed while the structure is used as a residence; and
 - iii. That all other building permit requirements are satisfied;
- b) That when a permit is requested for the 'Main House', a secondary permit will also be taken out for the renovations and repurposing of the garage-residence, as follows:
 - i. Permit A: Main House
 - The building permit application will follow the usual process; and
 - The usual building permit fees will be applicable;
 - ii. Permit B: Repurposing/renovation the garage-residence to a typical garage
 - The building permit application process for the renovations and repurposing of the garage-residence will vary according to the nature of the renovations in terms of fees and documentation required; and
 - No additional deposit will be required for permit B;
- c) The Deposit paid for Permit A will only be refunded once both permits A & B have been closed with all required inspections being completed satisfactorily; and
- d) Once the Main House is habitable, the applicant/owners will have 6 months to convert the garage-residence into a typical accessory building, unless otherwise permitted by the Municipality.
