RCC Grant Request

305-14 Saindon - Brunel

WHEREAS the Richer Community Club (RCC) attended the May 28, 2014 regular meeting of Council as a delegation to request a 10 year, \$60,000.00 per anum, grant to be used for the purchase of new equipment and the construction and/or renovation of facilities and amenities for the Richer Dawson Trail Park, with the proposed funding to come from a portion of the yearly Manitoba Hydro BiPole III Community Development Initiative funding to be received by the Municipality for a 10 year period;

BE IT RESOLVED that the grant request, as received verbally from the RCC, be denied for the following reasons, among others:

- a) The MB Hydro BiPole III CDI funds received to date have been deposited in a specific purpose reserve fund, created by By-Law #6-2014, and will remain there until Council makes a long-term commitment to a project on which the funds will be spent;
- b) Eligible projects under the above mentioned funding program include major infrastructure construction, including a wastewater management system for the LUD of Richer, for which Council is considering applying for P3 funding, as it is a project which the Municipality cannot necessarily pay for on it's own;
- c) Any grant request of the caliber requested is required to include a copy of last year's financial statements, showing the current financial position of the organization;
- d) The property on which the funding would be spent is not owned by the Municipality and, therefore, would not be shown as an asset on the Financial Statement of the RM of Ste. Anne but as an expense; and
- e) There are numerous Provincial and Federal funding opportunities for recreation projects which the RCC could apply for to provide a portion of the required money for the proposed projects.
