547-15 Courcelles - Eros

WHEREAS the Municipality has received a request to subdivide, as identified by File #4175-15-7501, in Pt. SW ¼ 15-8-7E, to subdivide a 75 acre parcel into 10 approx. 2 acre parcels, leaving the residual parcel at approx. 55 acres, in an area zoned "RR" Rural Residential;

AND WHEREAS a Hearing was held for Road Opening (RD) #01-15 which was approved by Resolution #509-15, for the creation of a new Public Road for proposed Phase 1 Subdivision File #4175-15-7501;

BE IT RESOLVED that the application for approval to subdivide, identified by File #4175-15-7501, is hereby approved on the following conditions:

- a) That the applicant obtain a Legal Plan, prepared by a Manitoba Land Surveyor, to determine the site widths, site areas and location of all buildings and/or structures including on-site wastewater management system(s) on the affected land in relation to the proposed property lines;
- b) That the applicant obtains any necessary variations as a result of the Legal Plan;
- c) That the applicant obtains all necessary site width variations for the proposed lots reducing the minimum site width from the required 200 feet in the "RR" zone to the measurements as determined by the Legal Plan;
- d) That a Development Agreement be entered into with the applicant/developer, including the establishment of a 30-meter undisturbed native vegetation area around the watercourse as recommended by MB Conservation and Water Stewardship, and that all conditions of the proposed subdivision and Road Opening be included in the Development Agreement to be registered as a caveat on the affected titles;
- e) That all costs associated with the registration of the Development Agreement be borne by the applicant/developer; and
- f) That a contribution of \$750.00 per parcel created be paid to the Municipality for municipal purposes.

11:15 am Stephen Walker, of Steinbach Community and Regional Planning Branch, attended the meeting to discuss proposed changes to the RM of Ste. Anne Development Plan.

S/D F#4175-12-5460 (Faucher)**554-15 Eros - Saindon**

WHEREAS the Municipality did receive a request to subdivide, as identified by File #4175-12-5460, in Pt. NW ¼ 14-8-7E, to subdivide an approx. 36 acre parcel, held under CT #2348744, to create an additional 8 approx. 3 acre lots, leaving the Residual parcel at approx. 12.4 acres, and to amalgamate an approx. 0.25 acre parcel south of Dawson Road with property in Pt. SW ¼ 14-8-7E held under CT #1900642, Lot 1 Plan 38630, all properties in an area zoned "RR" Rural Residential, which was conditionally approved by Resolution #478-15 at the September 23, 2015 regular Council meeting;

AND WHEREAS conditions "c)" and "d)" of Resolution #478-15 required that the Proposed Public Road shown in the concept plan, dated September 10, 2015, be instead called Parcel A and considered a shared driveway for Proposed Lots 1, 2 and 3, and that a Shared Driveway Agreement be entered into with the applicant/developer, to be registered as a caveat on the title;

AND WHEREAS the Municipality has now received an objection from MB Infrastructure and Transportation regarding the above-mentioned shared driveway and possible complications pertaining to future private accesses onto PR207;

BE IT RESOLVED that Council hereby waives conditions "c)" and "d)" of Resolution #478-15 and replaces them with the following conditions:

- a) That the 66 foot access to Proposed Lots 1, 2 and 3 be a Proposed Public Road, as indicated in the concept plan dated September 10, 2015;
- b) That a Road Opening hearing be held for the creation of a Proposed Public Road for Subdivision File #4175-12-5460;
- c) That the Road Opening be included in the Development Agreement, as outlined in condition "e)" of Resolution #478-15, to be registered as a caveat on the affected titles; and
- d) That all costs associated with the registration of the Development Agreement be borne by the applicant/developer.

BE IT FURTHER RESOLVED that the CAO be authorized to provide Council's instructions to the By-Law Enforcement Officer based on the by-law enforcement discussions.

Public Utilities Board**558-15 Courcelles – Reimer**

WHEREAS the RM of Ste. Anne requires that the following conditions are met for every utility installation:

- a) That the cable be buried away from any culverts or crossings;
- b) That the cable be buried to a minimum depth of 42 inches;
- c) The Ward Councillor be contacted prior to any works being done;
- d) The land shall be restored to its former state once the installation is completed;

AND WHEREAS the RM of Ste. Anne's Public Works, after requesting line locates prior to any works being done, frequently encounters MB Hydro and MTS Inc. lines which are buried at inconsistent depths and locations, which have not been installed in accordance with the above conditions, resulting in involuntary damage to the utility's infrastructure;

AND WHEREAS damaging the utility's infrastructure creates a safety hazard, not only due to the damaged lines, but also due to the interruption of service, which creates an unnecessary burden to municipal taxpayers;

BE IT RESOLVED that Council hereby requests that the Public Utilities Board complete a thorough review of its regulations, and enforcement of the same, pertaining to the placement of utility lines, specifically by MB Hydro & MTS Inc., to facilitate the protection of utility infrastructure and avoid charges to the municipality for the repair of damaged lines which were improperly installed by the utility companies.


