# Railway/Pipeline Tax Impact

# 418-15 Courcelles – Lansard

WHEREAS the Municipal Assessment Act Railway Roadway Property, Pipeline Property and Gas Distribution Systembs (2014) Regulation governs the basis by which Railways and Pipelines are assessed;

AND WHEREAS the RM of Ste. Anne's taxable assessment has only increased between 8.0 and 8.6% for pipeline and railway class assessments, in comparison to up to 19.6% for farm and 10.2% for residential property, resulting in a Municipal and School Tax decrease from 2015 to 2016 of between 4.4 and 5.0% for railways and pipelines, with an increase for farm property of 6.9% and a decrease of only 1.6% for residential property, as outlined in the Impact of Assessment 2016 for the RM of Ste. Anne, as submitted by the Regional Assessment Services Branch in Steinbach;

AND WHEREAS the increase in both the length of trains on the railway and volume of dangerous goods being transported through the RM of Ste. Anne, by both the TransCanada Pipeline and the railway, increase the tax burden on the Municipality due to infrastructure amendments and improvements, along with the greatened safety implications putting strain on preventative and reactive emergency measures in the Municipality;
