- 5. That a development agreement is entered into between the applicant/owner & the Municipality and that all conditions of the proposed subdivision and road opening be included in the Development Agreement to be registered as a caveat on the title;
- That the applicant submit an engineered drainage plan and obtain appropriate licenses under the Water Rights Act for all water control works to be registered as a caveat on the title;
- 7. That 10% of the property development is provided to the Municipality in land, cash, or a combination thereof, to satisfy municipal needs for recreational opportunities, open space and buffer zones;
