- That a development agreement be entered into with the Municipality and registered as a caveat on title to address municipal planning standards for the proposed public road and the location of development on the lots to ensure future infill opportunities are protected if sewer services become available;
- 4. That the recommendations put forth to Council through LUD of Richer Committee Resolution #37-19 pertaining to street lighting in the development be included in the Development Agreement outlined in Item 3; and
- 5. That a contribution fee of \$1,500.00 per parcel created be required.
