- 1. Between the earthen manure storage facility and the nearest residence (SW 17-7-7E) from 2625' to 804':
- 2. Between the earthen manure storage facility to the nearest non-agricultural designated area (Rural Residential Designated area: SW 5-7-7E) from 10499' to 9100'; and
- 3. Between the animal confinement facility (barn) to the nearest residence (SW 17-7-7E) from 1312 ' to 444':

WHEREAS numerous livestock (dairy) barns were destroyed by fire in early March 2019 on Pt. SW 1-7-7E, CT #1380057, and the property owner has expressed the urgent need to rebuild the buildings in order to protect the welfare of the animals;

AND WHEREAS this request requires careful consideration and review of the current and proposed use of the property in relation to the various Development and Zoning By-Law requirements in order to determine and draft the applicable applications needed to attempt to achieve compliance with municipal regulations;
