Prairie By-Law Enforcement - Request for Letter of Support

WHEREAS the Highway Traffic Act provides local governments with the authority to establish weight restrictions and speed limits on municipal roads by by-law;

AND WHEREAS the Enforcement Officers with Prairie By-law Enforcement Services have not been provided with the necessary authorities as Peace Officers required to stop and detain vehicles for the purpose of enforcing municipal traffic by-laws;

AND WHEREAS RCMP resources are unavailable to municipalities for the purpose of enforcing weight restrictions and speed limits on municipal roads, especially those under the authority of municipal traffic by-laws;

AND WHEREAS overweight vehicles and excessive speeds are detrimental to the health and safety of our municipal infrastructure, our residents, our wildlife and other travelers on transportations systems;

THEREFORE BE IT RESOLVED that the RM of Ste. Anne write a letter of support to Prairie By-law Enforcement Ltd. in their efforts to gain the authority to legally stop and detain vehicles for the purpose of enforcing municipal traffic by-laws enacted to protect local infrastructure and the living beings travelling on municipal roads.
