WHEREAS Council has reviewed the Subdivision File #4175-20-8366 Report to Council proposing to create two agricultural lots measuring 60.45 acres and 30.4 acres from the existing 90.01-acre holding CT#3038725; and to further subdivide a 3-acre rural residential lot and a 40.8 acre agricultural lot from the existing holding of 43.94 acres CT#2884128, being Parish of Ste. Anne River Lots 30 and 31, designated partially Agricultural Area and partially Agricultural Mixed Use Area and zoned partially Agriculture and partially Rural Mixed respectively;

BE IT RESOLVED that Subdivision File #4175-20-8366 be approved on the following conditions:

- That the applicant provide a copy of the Plan of Subdivision and a Building Location Certificate prepared by a Manitoba Land Surveyor including information on the area size of each lot;
- 2. That the Plan of Subdivision include the Ordinary High Water elevation for all lots along the river;
- 3. That the applicant obtain any necessary variations;
- 4. That the applicant enter into a Development Agreement with the Municipality to ensure that permanent buildings on the Proposed Parcels are confined within the flood protection level of 816.83 feet or if a house with a basement is built on land elevation below 816.83 feet, then it would require upwards of 4.8 feet clean, impervious fill;
- 5. That a contribution fee of \$1,500.00 per parcel created be required; and
- 6. That all costs including any legal and engineering costs incurred due to this subdivision be borne by the applicant.
