- 2. the relevant terms and conditions contained within the Access and Maintenance Agreement, pertaining to the construction of the road, be completed satisfactorily before the required building permit be issued for this previously used mobile home;
- 3. the recommendations included in the Structural Engineer's Report (Reference 22.338, stamped on January 20, 2023) be adopted as requirements;
- 4. building code compliance be confirmed through the building permit process, to the satisfaction of the municipally contracted building inspectors;
- 5. That any engineered and/or legal document pertaining to this subdivision may be reviewed by the municipal engineer and/or lawyer; and
- 6. That all costs, including any legal and engineering costs incurred by the Municipality due to this subdivision, are to be borne by the applicant.
