Rail Safety Week

WHEREAS *Rail Safety Week* is to be held across Canada from September 18 to 24, 2023; AND WHEREAS, 232 railway crossing and trespassing incidents occurred in Canada in 2022, resulting in 66 avoidable fatalities and 43 avoidable serious injuries;

AND WHEREAS, educating and informing the public about rail safety (reminding the public that railway rights-of-way are private property, enhancing public awareness of the dangers associated with highway rail grade crossings, ensuring pedestrians and motorists are looking and listening while near railways, and obeying established traffic laws) will reduce the number of avoidable fatalities and injuries cause by incidents involving trains and citizens; AND WHEREAS Operation Lifesaver is a public/private partnership whose aim is to work with the public, rail industry, governments, police services, media and others to raise rail safety

AND WHEREAS CN has requested Council adopt this resolution in support of its ongoing efforts to raise awareness, save lives and prevent injuries in communities, including our municipality; BE IT RESOLVED THAT Council support and proclaim the week of September 18 -24, 2023, as Rail Safety Week

Interim Construction Completion Certificate

WHEREAS current subdivision policies, being the Development Agreement and Municipal Service Standards, prevent building permits from being issued until the Construction Completion Certificate has been issued;

AND WHEREAS the Construction Completion Certificate initiates the commencement of a 1 year warranty period where the Developer must still maintain the planned area and repair any defects, if any, prior to the RM taking over the maintenance and repairs;

AND WHEREAS the Construction Completion Certificate can only be issued once all required work has been completed to the satisfaction of the Municipality;

AND WHEREAS erosion control is one of the conditions required to be satisfied, a condition which can take years to be successfully completed;

AND WHEREAS vegetation growth should not hinder the ability of new homes to be built in these new subdivision where every other condition has been satisfied;

BE IT RESOLVED THAT Council authorize the Municpal Team, being the Designated Officers and Municipal Engineers, to grant Interim Contruction Completion Certificates that would enable to release of building permits, but not initiate the commencement of the 1 year warrantee period; BE IT FURTHER RESOLVED THAT this Interim Construction Completion Certificate Policy be consolidated with the Municipal Service Standards upon in next revision.
