# Hearing Decision - RO #01-25 - SD #4175-24-8998 - Commerce Lane - Owen Reimer 2025-149

WHEREAS a Public Hearing was held for Road Order #01-25, in relation to Subdivision File #4175-24-8998, proposing to create twelve (12) commercial lots (10 new lots) from the current 24.58-acre area held under CTs #2397016/1 and #3233532/1, being Parts of RL 23 & 24 Parish of Ste. Anne including Parcels 1& 2 Plan 9728 WLTO, in an area zoned "Highway Commercial"; AND WHEREAS the proposed development includes the extension of municipal services and the creation of a new public road to be named *Commerce Lane*;

BE IT RESOLVED THAT Council approve Road Order #01-25 and Subdivision File #4175-24-8998, subject to the following conditions:

1. That the developer provide a geotechnical report prepared by a qualified geotechnical engineer for the planned area, identifying groundwater conditions, soil composition, and foundation design recommendations;

- That the developer provide an engineered drainage and road design plan, including the construction of Commerce Lane, in accordance with the RM of Ste. Anne Municipal Standards and approved by the Municipal Engineer;
- 3. That the developer enter into a Development Agreement with the Municipality, addressing, among other matters:
  - a. the construction of Commerce Lane and any required road upgrades,
  - b. drainage infrastructure,
  - c. street lighting,
  - d. site servicing provisions,
  - e. fencing and any other applicable buffering requirements.
  - f. that a mention of the Town of Ste. Anne force-main's presence be included in the development agreement which may affect development in its vicinity.
- 4. That drainage easement must be registered in a form acceptable to the Municipality;
- 5. That the applicant obtain any necessary variations and pay the associated variation order fees;
- 6. That any non-conforming uses or buildings be brought into compliance with municipal Zoning By-law requirements to the satisfaction of the Designated Officer.
- 7. That the developer provide a digital and hard copy of the Plan of Subdivision prepared by a Manitoba Land Surveyor, including lot areas in acres for all proposed planned area, and a Building Location Certificate for proposed lots 8 & 9;
- 8. That the road name *Allée du Commerce Lane* be clearly shown on the Plan of Subdivision;
- 9. That the developer pay the applicable subdivision administration fee of \$1,100 in accordance with By-Law 21-2023;
- 10. That a lot levy of \$2,000.00 per lot created be paid to the Municipality, for a total of \$18,000.00;
- 11. That \$6,840.00 dedication fee be paid to the Municipality in lieu of public reserve or school lands, in accordance with Section 136(1) of The Planning Act and Policy #03-ADMIN. Should design plans change, the allocation between cash and lands may be revised, provided that the 10% allocation for public reserve purposes is met under this Policy.
- 12. That any engineered or legal documents related to the subdivision be subject to review by the Municipality's consulting engineer and/or legal counsel; and
- 13. That all costs associated with the subdivision, including but not limited to legal, engineering, and registration fees, be borne by the developer.

BE IT FURTHER RESOLVED THAT, should Manitoba Transportation and Infrastructure (MTI) require the closure of the existing access to the RM Public Works yard from PR 210, the Development Agreement shall include provisions to:

- Redesign the affected municipal lot to the satisfaction of the Municipality, ensuring continued public and emergency access to the water line, Clean Farms depot, residential recycling depot, and the Park & Ride lot;
- Include, if necessary, relocation of these services or construction of alternate access points, while minimizing the interaction between heavy equipment and passenger vehicles;
- Ensure all associated work is completed at the Developer's cost, in a timely manner, with prior Municipal approval, and without disruption to ongoing municipal operations.
