MMAA Request - Increase MWSB Funding

WHEREAS the Province of Manitoba released their Economic Development Strategy on September 25, 2025, which includes as a part of their Pillar 2: Boost Trade & Investment, to Work with municipalities across Manitoba to improve waste-water management and to ensure water/wastewater services are available to support economic development;

AND WHEREAS Canada, including Manitoba, is experiencing a housing crisis, with both the Federal and Provincial governments having implemented measures to address this critical issue; AND WHEREAS Canada, including Manitoba, is also experiencing economic pressures globally, and is looking to increase and strengthen our economy;

AND WHEREAS both economic development and housing developments are entirely dependent on, and limited by, the capacity of municipal wastewater treatment facility;

AND WHEREAS the vast majority of Manitoba municipalities are in dire need of the Manitoba Water Services Board (MWSB) financial, professional, and / or related subject matter expertise assistance for every aspect of water and wastewater projects and initiatives;

AND WHEREAS the demand for MWSB assistance far outweighs its current ability to meet, thereby hindering Manitoba communities' ability to implement their housing and economic development projects, further hurting both provincial and national goals;

THEREFORE BE IT RESOLVED THAT the council of the RM of Ste. Anne fully supports an immediate annual increase to the MWSB's capital budget, beginning in 2026, to \$100 million from its current \$24 million.

WHEREAS the Ste. Anne Aces have been a long-standing and successful member of various Senior leagues including the South Eastern Manitoba Hockey League (SEMHL), contributing to the tradition of senior hockey in Manitoba;

AND WHEREAS the SEMHL has recently taken steps to remove the Ste. Anne Aces from participation in the 2025-2026 season;

AND WHEREAS this decision will have significant negative impacts, including:

- The loss of an important pathway for young players in Ste. Anne and surrounding areas, undermining the grassroots development of hockey.
- A financial impact on the Town of Ste. Anne and its arena operations, reducing facility usage and local economic spinoffs.
- A weakening of senior hockey in Manitoba at a time when maintaining strong and viable organizations is critical for the sport's sustainability.
- The erosion of community identity and spirit, as the Aces have long been a source of pride and engagement for residents.
- A reduction in opportunities for regional competition, fan engagement, and tourism activity that benefits not only Ste. Anne but surrounding municipalities as well.

THEREFORE BE IT RESOLVED THAT the RM of Ste. Anne formally requests that the South Eastern Manitoba Hockey League reconsider its decision to remove the Ste. Anne Aces from the 2025-2026 season;
