UNFINISHED BUSINESS

2017 Paving

The LUD of Richer Committee is considering paving and repairing some streets in the LUD of Richer in 2017. At the August 3, 2016 LUD of Richer Committee meeting, the following was proposed:

- That Therrien Drive and the Hwy #1 Service Road (from Godard Street to PR302) be paved;
- That the paved portion of Dawson Road be extended east to Road 45E; and
- That Hwy #1 service road from PR 302 to the Civic #43126 be maintained/repaired.

Freddy Hernandez from Hugh Munro Construction was scheduled to appear as a delegation, but cancelled. Attempts will be made to reschedule for the March 1, 2017 LUD meeting.

Chairman Roger Godard is in the process of obtaining more information to be brought to the Committee at the next LUD Meeting.

2017 Draft Financial and Service Plans

The draft 2017 Financial Plan as well as the accompanying Service Plan were presented to the Committee for discussion purposes only as 2016 final expenses & revenues are not yet available. Discussions continued regarding proposed 2017 projects. Amendments to the draft 2017 LUD Financial Plan will be made accordingly. The matter will be revisited in March 2017 when more information is available.

Recycling Shed Garbage Pick-up

At the December 7, 2016 LUD of Richer Committee meeting, Resolution #151-16 was passed approving quotes to be obtained for 2017 garbage removal services to be provided at the LUD Recycling Shed within 48 hours of the scheduled recycling pick-up. A draft Notice was approved by the Committee and advertized following the January 4, 2017 meeting. Two submissions were received. See Resolution #15-17 below.
