WHEREAS Variation Order file #09-18 proposes to vary Section 5.6 of Part IV of the amended Zoning By-law #10-2010 in order to define "Dwelling, multiple-family" to mean two detached buildings, each containing 4 dwelling units, each unit designed for and used by not more than one family, for a 2.29 acre property being Lot 16 Plan 47650 in the Residential zone in the LUD of Richer;

AND WHEREAS Variation Order file #09-18 further proposes to vary the minimum site area requirement from 7 acres to 2.29 acres to allow for a total of 8 dwelling units on the subject property described above;

AND WHEREAS Conditional Use file #05-18 proposes to allow for Multiple Family Dwellings as defined above on the subject property also described above;

BE IT RESOLVED THAT the LUD of Richer Committee recommend Council approve VO#09-18 and CU#05-18 on condition that prior to any occupancy being permitted, that all finishing including landscaping, be completed to the satisfaction of an authorized Municipal Agent.
