## 136 Dawson Rd - Access Widening

At the June 1, 2016 LUD of Richer Committee meeting, the Richer Rodeo Committee requested a wider approach to the Richer Park for the annual Rodeo to be cost shared equally between the LUD of Richer, the Richer Fire Department and the Richer Rodeo Committee for a total estimated cost of \$2,500. The LUD of Richer Committee passed Resolution #67-16 agreeing to this request and the RM of Ste. Anne Council authorized the same with Resolution #283-16. Chairman Roger Godard stated that all works have now been completed and estimates a total cost of roughly \$2,000.00.

## 2016 Sidewalk Construction - Update

Chairman Roger Godard stated that the 2016 sidewalk construction is now complete with the exception of grass seeding the boulevards and that homeowners should be able to drive over it by the end of the week. The Committee is very pleased with the work that was completed and passed Resolution #94-16 as follows:

#### 94-16 Lenton - Saindon

BE IT RESOLVED that the LUD of Richer Committee recommend to the Council of the RM of Ste. Anne that the remaining \$20,000 be released upon receipt of the final invoice from PPM Developments.

#### **Damaged Sidewalk**

Ward 3 Councillor Paul Saindon brought to the Committee's attention that during the installation of a new electric pole at #7 Dawson Road W, there were some damages done by Manitoba Hydro to the sidewalk that was constructed in 2014. Chairman Roger Godard stated that he would be addressing Manitoba Hydro to see what can be done to remedy the situation.

#### 35 Dawson Rd E - Blvd Repairs

At the April 6, 2016 LUD of Richer Committee meeting, Resolution #40-16 was passed contracting Henry Proteau to repair and reseed the boulevard that was left damaged following the 2015 sidewalk construction project. To date, the works have not been completed. Chairman Roger Godard stated that he would make the necessary arrangements to have this completed.

#### **NEW BUSINESS**

#### 2017 Paving

The LUD of Richer Committee is considering paving and repairing some streets in 2017. After a brief discussion, it was decided:

- That Therrien Drive and the Hwy #1 Service Road (from Godard Street to PR302) be paved;
- That the paved portion of Dawson Road be extended to Road 45E;

Chairman Roger Godard will be looking into the options for the type of materials to be used and bring back his finding to the committee.

#### **COMMITTEE MEMBER COMMENTS**

Councillor Paul Saindon reported that sites are being investigated for suitability for a potential new lagoon.

Chairman Roger Godard reported the following:

- the new Marquee Lane development off of Southwest Drive is now advertising lots for sale;
- candy for the Richer Rodeo Parade had been ordered from Burnells Food Plus for between \$100 to \$150;
- Allen Durocher will be mowing the Dawson road ditches and around the MTS Building and the Saindon Drive turnaround.
