Chairman Roger Godard called the meeting to order at 7:09 pm with the following Committee members present: John Lenton and Brent Wery. Paul Saindon, Ward 3 Councillor for the RM of Ste. Anne and recording secretary Nadine Vielfaure, ACAO for the RM of Ste. Anne, were also present.

ADOPTION OF AGENDA

99-16 Saindon - Wery

BE IT RESOLVED that the agenda for the regular LUD meeting of September 7, 2016 be adopted as presented and amended.

UNFINISHED BUSINESS

136 Dawson Rd - Access Widening

At the June 1, 2016 LUD of Richer Committee meeting, the Richer Rodeo Committee requested a wider approach to the Richer Park for the annual Rodeo to be cost shared equally between the LUD of Richer, the Richer Fire Department and the Richer Rodeo Committee for a total estimated cost of \$2,500.00. The LUD of Richer Committee passed Resolution #67-16 agreeing to this request and the RM of Ste. Anne Council authorized the same with Resolution #283-16. All works have since been completed with a total cost of \$2,427.22, with \$809.07 being borne by each party.

Damaged Sidewalk

At the August 3, 2016 LUD of Richer Committee meeting, Ward 3 Councillor Paul Saindon brought to the Committee's attention that during the installation of a new electric pole at #7 Dawson Road W, there were some damages done by Manitoba Hydro to the sidewalk that was constructed in 2014. Chairman Roger Godard addressed the matter with Manitoba Hydro and informed the Committee that MB Hydro will be covering the cost of the repairs. Chairman Roger Godard stated that he was acting as an intermediary for MB Hydro and obtaining quotes on their behalf.

35 Dawson Rd E - Blvd Repairs

At the April 6, 2016 LUD of Richer Committee meeting, Resolution #40-16 was passed contracting Henry Proteau to repair and reseed the boulevard that was left damaged following the 2015 sidewalk construction project. Chairman Roger Godard stated that all works have now been completed.

At 7:31 pm Chairman Roger Godard declared an interest in the following matter and left the LUD Hall during the discussion and voting on Resolution #'s 103 to 105-16.

103-16 Wery - Saindon

BE IT RESOLVED that Committee member Brent Wery be hereby appointed to act as Chairman during the discussion and voting pertaining to Resolution #104-16.

2017 Paving

The LUD of Richer Committee is considering paving and repairing some streets in 2017. At the August 3, 2016 LUD of Richer Committee meeting, the following was decided:

- That Therrien Drive and the Hwy #1 Service Road (from Godard Street to PR302) be paved;
- That the paved portion of Dawson Road be extended to Road 45E; and
- That Hwy #1 service road from PR 302 to the Hotel be maintained/repaired.

Chairman Roger Godard will be looking into the options for the type of materials to be used and bring back his finding to the committee.

Dawson Rd E - Drainage Works

At the October 7, 2015 regular meeting of the LUD of Richer Committee, Resolution #108-15 was passed authorizing Orlando Hiebert to survey the southern ditch of Dawson Road E between 64 Dawson Rd E and PR 302, including culvert elevations. Drainage licence No.11-WCW-0661, which includes this area of concern, was presented to the LUD Committee for review. It was agreed that the ditches should be returned to their original state in accordance with the existing license. After a brief discussion, Resolution #106-16 was passed:

106-16 Lenton - Saindon

BE IT RESOLVED that the Council of the RM of Ste. Anne be requested to authorize Chairman Roger Godard to make the necessary arrangements to return the northern Dawson Road ditch, from PR 302 eastward to #35 Dawson Road E, back to its original licensed state as per Drainage Licence No. 11-WCW-0661, up to an approximate total cost of \$4,500.00.

Perimeter Road Northwest re: Drainage Works - Tabled

Culvert Extension – SE Dr @ PR302

As the installation of the annual Christmas lights at the northeast corner of Southeast Drive and PR 302 is difficult and hazardous due to the steep incline of the drainage ditch and the presence of MB Hydro guide wires, a culvert extension was proposed in order to enlarge the existing access.

107-16 Saindon - Wery

BE IT RESOLVED that the Council of the RM of Ste. Anne be requested to authorize Chairman Roger Godard to make the necessary arrangement to have the culvert extended at the Northeast corner of Southeast Drive and PR 302, to a maximum cost of \$500.00.

Proteau Drive - Upgrades Required

A permit request has been received for a new house on Proteau Drive. Considering the area is being developed, the RM of Ste. Anne and the LUD of Richer are therefore required to ensure that this road be of adequate quality for regular use. During their September 7, 2016 regular day meeting, the RM of Ste. Anne has requested that the LUD of Richer Committee approach the Developer to have the road gravelled and graded, after which the RM will take over the regular maintenance of the road, with the expense being borne by the LUD of Richer. Chairman Roger Godard stated that approximately 66 yards of A-Base has since been applied to the road and graded.
