## 2017 Paving

In 2016, The LUD of Richer Committee proposed the following projects:

- -Pave Therrien Drive and the Hwy #1 Service Road (from Godard Street to PR302);
- -Extend the paved portion of Dawson Road east to Road 45E; and
- -Maintain/repair Hwy #1 service road from PR 302 to the Civic #43126.

John Lenton and Roger Godard attended the regular meeting of Council at 11:22am on March 8, 2017 on behalf of the LUD of Richer Committee to propose the hard-surfacing of these LUD roads and streets, and request authorization and cost sharing from the Municipality. Council then passed Res #2017-119 to put out a call for tenders for the hard-surfacing of various roads in the LUD of Richer, as per the Municipal Tendering and Procurement Policy, with all associated costs to be paid by the LUD of Richer and that \$100,000.00 will be included in the 2017 RM of Ste. Anne Financial Plan for the project and, should a tender be accepted by Council, to be contributed towards the costs of the works, with arrangements to be made for financing any remaining costs after both the Municipal and LUD of Richer contributions are applied, the financing debenture payments are to be paid by the LUD Of Richer.

Tabled until the RM of Ste. Anne Financial Plan is passed.
