WHEREAS Variation Order #05-22 and Conditional Use Order #09-22 and Permit #53-22 for a Rail Car Storage Container for the LUD of Richer Committee to be located at 136-142 Dawson Road were approved by Council Resolution #2022-296 on June 22, 2022;

AND WHEREAS the Operations Manager obtained two quotations for the renovations to the LUD of Richer Rail Car Storage Container;

AND WHEREAS discrepancies were found between these quotes;

BE IT RESOLVED THAT the LUD of Richer Committee request new quotations be obtained to renovation the rail car storage container in order for it to have a pitched roof and finished to match surrounding buildings and generally appear as a conventional shed with the following criteria to be included for works required:

- all materials and labour for rafters, siding, and finishing
- finishing to be tin roof and sheet metal siding matching the fire hall; and
 - minimum 12" overhangs all around.

2022 LUD Sidewalk Construction Update

WHEREAS the 2022 LUD of Richer Financial Plan included provision for \$110,000 of sidewalk construction;

AND WHEREAS LUD Resolution #LUD-2022-52 reduced the scope of the 2022 project from 2,175 feet to roughly 1,300 feet due to quotations exceeding the original budget amount; AND WHEREAS the Municipal Service Standards require a wider sidewalk than previously existed, and current utility infrastructure limits the ability to construct the new sidewalk to the full width of the standards at that same location, thus requiring a relocation of the sidewalks further into the Municipal Right of Way;

AND WHERAS this slight relocation leads to a need for increased fill materials due to the slope of the undeveloped boulevard increasing the projected costs by roughly \$10,000; BE IT RESOLVED THAT Council be recommended to authorize the necessary works to be completed under the direction of the Operations Manager including accommodations necessary to satisfy Municipal Standards for an additional cost not to exceed \$10,000. Subdivision Application # 4175-22-8609 - SE 17-8-8E - Tschritter

WHEREAS a public Hearing will be held on July 13, 2022 for Road Order #03-22 and Subdivision File #4175-22-8609 proposing to create eleven residential lots from the current approx.26.64-acre lot held under CT #2986594 on SW 17-8-8E in an area zoned Residential General and Agricultural Limited in the Local Urban District of Richer;

BE IT RESOLVED that Council be recommended to approve Subdivision File #4175-22-8609 on the following conditions:

- 1. That the subject property be satisfactorily re-zoned from "AL" Agriculture Limited to "R" Residential General;
- 2. That the developer provide a copy of the Plan of Subdivision and a Building Location Certificate prepared by a Manitoba Land Surveyor;
- 3. That the developer provide a the area size of each lot in acres prepared by a Manitoba Surveyor;
- 4. That Road Names "Dallas Drive" and "Bauman Ridge" be included on the Plan of Subdivision;
- 5. That the developer obtain any necessary variations;
- 6. That the developer provide a geotechnical report prepared by a geotechnical engineer including information on the soil stratigraphy, groundwater elevation, maximum recommended depth of excavation, soil strength, and recommendations on foundation design requirements and recommended construction methodology, for all newly created building lots;
- 7. That the developer provide an engineered road and drainage plan, including a pathway on one side of the proposed new roads connecting to the pathway along Bauman Ridge in accordance with Municipal Standards; (correspond with developers to the north, Schinkel Properties, on which side they are doing a pathway, in order to have a continued pathway)
- 8. That any required easements be provided to the Municipality in form of Easement Agreements;
- 9. That the property owner enter into a development agreement with the Municipality addressing the required geotechnical report requirements as well as the construction of

- municipal services, building restrictions on the proposed lots to enable future subdivision of the land when municipal services are available, among others;
- 10. That the subdivision administrative fee of \$1,100 be required in accordance with By-Law 07-2011;
- 11. That a lot levy of \$1,500.00 per parcel created be required; and
- 12. That all costs including any legal and engineering costs incurred due to this subdivision be borne by the applicant; and
- 13. That Proposed Lot 6 be designated a public reserve for a municipal park to be developed at a later date, in accordance with Section 136(1) of *The Planning Act* and Policy #03-ADMIN, with the park to be named by the Developer;
