2026-2030 Curbside Garbage Contract

BE IT RESOLVED THAT Council be recommended to enter into a five-year agreement with Jon's Deck Aid & More for manual weekly curbside garbage collection services, effective January 1, 2026, under the authority of Special Service Levy By-law #2023-15 as outlined in their proposal, for \$7.20 + GST per unit per month, based on 270 units, for 2026, totalling approximately \$23,328 plus GST, with an annual increase as outlined in the proposal.

BE IT FURTHER RESOLVED THAT Council be requested to support the limits established by the contract and enforce a maximum 5 bag limit per unit served.
