**IDENTIFICATION MAY BE REQUIRED BEFORE BEING ALLOWED TO VOTE.** A person may be required to produce one piece of government issued photo identification (for example - driver's license) or at least two other documents that provide proof of identity.

## **ADVANCE VOTING**

For the purpose of accommodating persons who are qualified to vote, but who have reason to believe that they will be absent or otherwise unable to attend their proper voting place on Election Day, an advance voting opportunity will be located at the Rural Municipality of Ste. Anne Office, 395 Traverse Road, Ste. Anne, Manitoba, and will be open Saturday, October 15, 2022 between 8:00 a.m. and 8:00 p.m.

## **APPLICATION TO VOTE BY SEALED ENVELOPE**

A voter who is unable to go in person to the voting place or vote in advance, may apply in person, in writing, or by email to the Senior Election Official at the Rural Municipality of Ste. If applying in person\*, a voter may apply between September 28 and October 23, 2022.

\*A voter applying in person may pick up a sealed envelope ballot package at the time of application.

If applying by mail or email\*\*, a voter may apply between July 28 and October 23, 2022.

\*\* A voter applying by mail or email will receive a sealed envelope ballot package by regular post, or by making alternative arrangements with the senior election official.
