 - b) That when called by a member of the public works committee, he is to report to that person within 1 hour of the time called and failing to do so he forfeits the guaranteed hours for that day;
 - c) That he be available for duty all day;
- 4. That he be available to work on Saturdays and Sundays as required;
- 5. That he perform his duties upon direction from the Transportation Committee as appointed by council and to perform such other work as he may be directed from time to time;
- 6. That his duties and responsibilities as Public Works Supervisor and Grader Operator be established as recommended by the Transportation Committee and approved by Council;
- 7. That during the winter months he be reimbursed for the cost of a hot meal, to a maximum of \$12.00, including taxes, after 10 hours of continuous work; (Receipts must be submitted)
- 8. That he be given a minimum of three months notice if he is to be laid off because the municipality chooses to contract out road maintenance;
- 9. That the terms and conditions forming part of this resolution be reviewed annually.
