Purpose: The expansion of an existing livestock dairy operation to greater than 200 animal units (from current 450 animal units to a maximum of 1200 animal units), with 2 new barns to be constructed.

Representation: Gary Plohman and Cheryl Warkentine on behalf of Rising Hope Dairy Inc.

Don Malinowski of the Technical Review Committee summarized the Technical Review Committee's report.

**Opposed:**

There were 2 objections received at the Municipal office and 2 members of the public raised concerns during the hearing.

**In support:**

Gary Plohman, Cheryl Warkentine and Alvin Plett spoke in favour of this proposal on behalf of Rising Hope Dairy and emphasized their focus on responsible and accountable farming practices.

**No concerns:**

There was one letter received from the RM of Tache indicating that their Council had no concerns with the proposal.

Reeve Art Bergmann thanked everyone for coming and reiterated that no decision would be made during this meeting.

Reeve Bergmann closed the Technical Review Public Hearing for Rising Hope Dairy at 7:56 pm.




