 - i. Insurance coverage including general and environmental liability;
- 2. That the applicant be required to provide proof of satisfactory completion of the requirements of the Historic Resources Branch;
- 3. That the developer maintain a valid Water Rights License and a drainage plan, if required by the Provincial Drainage Licensing Branch;
- 4. That the aggregate fees be paid in accordance with the Municipality's Aggregate Fees By-Law.
