PR 302 @ Dawson Road - 4-Way Stop Request - Update

WHEREAS the LUD of Richer Committee's request to have the Province of Manitoba's Department of Infrastructure and Transportation install a 4-way stop sign at the intersection of Dawson Road and PR 302 has been denied;

AND WHEREAS, among other factors, the response from MTI indicated that there was only 1 documented incident at this location in the past 5 years, being 'well under the threshold' according to the Transportation Association of Canada Manual of Uniform Traffic Control Devices for Canada to warrant a change in the current controls for this intersection; AND WHEREAS, in the interest of public safety, and in light of the undocumented incidents and near-misses with pedestrians that occur on a regular basis at this location;

BE IT RESOLVED THAT Council appeal this decision using the most appropriate mechanisms, including lobbying the Province to review this decisions and take pro-active measures to improve vehicle and pedestrian safety at the intersection of PR 302 and Dawson Road in Richer.

WHEREAS Age Friendly Manitoba has launched a new grant opportunity for Age Friendly Municipalities to receive up to \$10,000 to support a collaborative community age-friendly initiative;

AND WHEREAS the Municipality has shared this opportunity with local community groups, and have received a request to launch a recurring low-cost soup & sandwich community lunch opportunity at the Richer Young at Hearts Club, proposed from January to May 2025, with transportation proposed from our main seniors centers (Paradise Village and Villa Youville); AND WHEREAS this initiative, open to the public but generally aimed towards our 55+ demographic, will provide transportation, reduce social isolation, promote health and wellness, and offer lower cost meals for participants, among other individual and community benefits, which aligns with the RM of Ste. Anne's goals for being an Age-Friendly Community; BE IT RESOLVED THAT Council proudly sponsor the Age Friendly Community Collaboration Grant application for this Soup & Sandwich initiative, in collaboration with the Richer Community Club, Richer Recreation Committee, Seine River Services for Seniors, Richer Metis Local, with involvement from local businesses and organizations from the Richer and surrounding area; BE IT FURTHER RESOLVED THAT Council authorize administrative support, if needed, to help coordinate this initiative, and financial support up to \$1,000.00, to be funded from the general operating Grants Budget.

WHEREAS a Public Hearing was held for Conditional Use #19-24 to allow a shipping container to be moved on-site at 88 Tall Grass Road, SW 5-7-7E, in an area zoned Rural Residential AND WHEREAS a previous Public Hearing for Conditional Use #16-24 for the same proposed use and location was held on September 11, 2024, and Council passed Resolution #2024-401, determining that additional information was required and requesting a new hearing at no cost to the applicant:

AND WHEREAS Council seeks to ensure that any conditional use approval balances the interests of both the applicant and the surrounding community;

BE IT RESOLVED THAT Conditional Use #19-24 be conditionally approved subject to the following conditions:

- 1. The shipping container shall be placed in the backyard of the property, to minimizes the visual impact on neighboring properties.
- 2. The applicant shall be responsible for maintaining the appearance of the shipping container.
- 3. Upon request of the Municipality, the applicant must install fencing and/or trees around the shipping container to reduce its visual impact on neighboring properties.
- 4. The shipping container shall be used for storage for any approved/permitted use onsite; any other use may require appropriate permissions.
- 5. This approval is only valid for the current owners and becomes void upon title changes reflecting new ownership.
